

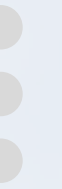

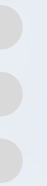

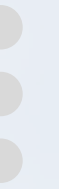

# HLC Assurance Argument: Timeline

- Criterion Teams work through the Summer to collection evidence
- 08/2023: Teams begin drafting narrative, select evidence
- 03/2024: Teams submit complete draft for review to AOL
- 04/2024: The draft is reviewed for tone, consistency, errors
- 05/2024: Draft is presented to UQC
- Edits continue throughout, evidence organizations, etc
- Assurance Argument submitted to Provost for review October 2024
- Lock date in the Assurance Argument System: **March 1, 2025**
